1/08/08 - Michigan Credit Union League President David Adams and EVP Patrick La Pine addressed 35 credit union professionals at the Oakland County Chapter meeting held at T&C FCU. David Adams presented information on ten strategic initiatives that the MCUL will focus on in 2008. He also addressed the housing and mortgage crisis and explained the objectives of the Housing and Mortgage Summit scheduled for 1/10/08. Patrick La Pine discussed hot legislative issues for the credit union industry, including updates on CURIA and housing/mortgage crisis legislative initiatives.

Representatives of the Oakland Livingston Human Services Agency attended the meeting to encourage credit unions to participate in the 2008 Walk for Warmth.
